ANNUAL AUDIT


The annual member audit will occur in April 2023. If you have been selected, you will receive an email indicating that the following three items must be provided:

- Professional practice hours
 - A minimum of 1200 MRT practice hours in primary discipline and 300 practice hours in any additional discipline in the previous 5 years;
- ✓ Have a minimum of 10 CE Credits; and
- ✓ Hold professional liability insurance.

Proof of the above must be uploaded to the portal by the deadline identified in the email. You will be notified if there are any issues with your submission. Members will only receive confirmation of passing the audit after the Continuing Education Committee has met, expected to occur in May.

DIAGNOSTIC MEDICAL SONOGRAPHERS

Amendments to *The Medical Radiation Technologists Act,* 2006 to regulate sonographers was folded into Bill 120 and is expected to continue through to committee, a third reading in the legislature, and receiving Royal assent, possibly as soon as the Spring session. It will not be immediately proclaimed for SAMRT to ensure there is appropriate time to prepare to regulate a fifth discipline – the Diagnostic Medical Sonographers.

PROGRAM EXPANSION

The Saskatchewan Government announced health care training expansion through the Health Human Resources Action Plan focusing on **Recruit, Train, Incentivize** and **Retain**. It covers 18 health occupations with a total expansion of 550 new training seats with most of the seats available by fall 2023. What does this mean for your profession?

- Medical Radiation Technologists seats will be expanded from 20 to 40.
- Magnetic Resonance Imaging Technologist seats will be expanded from 2 to 14.
- Diagnostic Medical Sonographer seats will be expanded from 24 to 40.

NEW SAMRT MEMBER

The SAMRT has hired a new team member. Dianne Walker has been recruited into the Manager, Communications and Competency Assurance role on a part-time basis. She will largely be responsible for generating the annual report, newsletter, minutes of council meetings, and miscellaneous correspondence as well as leading both the annual audit process and the new jurisprudence project and serving in the capacity of Deputy Registrar when required.

STRATEGIC PLAN
