

## SAMRT Council

The SAMRT Council is made up of 3 government appointed representatives, and 8 elected MRT members. Council members serve a three-year term, effective January 1.

- President
- Vice-President
- Past President
- Five-member at large positions
- Three appointed public representatives

## Role of Council

Council members are accountable for the overall governance of the College, which includes:

- Acting as one, in the best interests of the public.
- Defining strategic direction for the college.
- Overseeing fiscal management of the college.
- Appointment of the executive director of the college.
- Avoiding conflict of interest.
- Respecting confidentiality.
- Ensure compliance with legislation requirements under the Saskatchewan Medical Radiation Technologists Act, 2006, and the Regulatory and Administrative Bylaws.

## Expectations

1. Council members will attend meetings on a regular and punctual basis.
2. Council members will sign a confidentiality agreement.
3. Council members will attend an orientation and participate in a shadowing period prior to the start of their Council term.
4. Council members must consider the protection of the public in all decisions.
5. Council members will be familiar with important SAMRT documents such as *The Saskatchewan Association of Medical Radiation Technologists Act and Bylaws*.



**The council shall govern and regulate the affairs and business of the association.**

**It is the duty of the association at all times:**  
*(a) to serve and protect the public; and  
(b) to exercise its powers and discharge its responsibilities in the public interest and not in the interests of the members.*

Serving on council will provide many opportunities for personal and professional growth such as:

- Developing leadership and organizational skills by chairing or/and participating in committee and Council meetings;
- Gaining a broader view of the profession from within and from the public's perspective;
