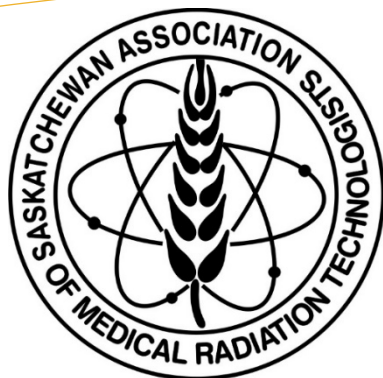

### Virtual Platform

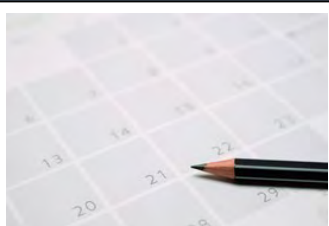
The SAMRT Council has set the date for the AGM and have also directed that the meeting be virtual.

## Annual Member Audit Results

Dec. 1, 2019, to Nov. 30, 2020

The SAMRT Continuing Competence Committee met virtually on June 9, 2021, to review audit submissions. Sixty-three members were audited, with all submissions arriving on time, and all were accepted as presented, or have completed remediation to bring the submission in line with requirements. For the first time, members were able to upload their documents to their member portal making submission and review much easier.

In addition to the audit review, the committee also reviewed the audit guidelines, forms, and certificates. Updates will be posted to the website by fall.

Finally, the committee participated in a preliminary discussion to help guide the development of the Jurisprudence Program. This is an important goal in the SAMRT 3-year strategic plan. We look forward to sharing more details about this important project as the plan takes shape.



This comparator chart, adapted with permission of The Alberta College of Medical Diagnostic and Therapeutic Technologists highlights key differences in the role a regulator plays compared to an association.

Aspect	Regulator (e.g., SAMRT)	Association (e.g., CAMRT)
Mandate	To serve and protect the public, and to act in the public's interest and not in the interest of the members	Acts in the interest of the members of a profession.
Accountability	Is accountable to the public through the provincial government.	Is accountable to its members.
Activities	Sets the Scope and Standards of Practice, Code of Ethics, and qualifications, standards, and tests of competency requirements for the practice of a profession.	Serves and supports its members through education, advocacy, professional liability insurance and member benefits.
Registration vs. membership	Registers members based on legislated criteria. Membership is mandatory to practice.	Accepts members based on association determined criteria. Membership is voluntary.
Permit vs. certification	Issues permits (licenses), which are legally required to practice in the jurisdiction.	Issues certification, which encompasses criteria to enter practice.
Qualifications	Sets registration requirements (education, entry to practice, practice hours, professional liability insurance, requirements of sound character).	Creates and facilitates certification examinations.
Competency profiles	Approves or selects the competency profile(s) for a profession.	Maintains competency profile(s) for a profession.
Life-long learning	Requires members to participate in legislated programs to ensure continuing competence.	Provides members with opportunities for continuing education.
Standards of practice vs. enhancement of practice	Sets legal standards of practice to ensure safe, competent, and ethical service for the public.	Provides opportunities to augment competency for members seeking to expand their practice.
Protected titles vs. credentials	Establishes professional titles protected in legislation that inform the public of authorized practitioners — e.g., RTR, RTT, RTMN or RTMR. Practitioners <b>must</b> use these titles in their practice.	Issues credentials to those who have completed certification requirements — e.g., ACR, CIR, CTIC PET/CT, DCR. Practitioners <b>choose</b> to use these titles in their practice.
Enforcement of standards	Has a legislated complaints and discipline processes in place to address complaints from the public and professional conduct issues.	Provides support to members through offering professional liability insurance (PLI).
Advocacy	Performs no overt advocacy work. It collaborates with government, professionals, and the public to ensure safe, competent and ethical care.	Advocates for the profession to effect changes to service delivery, to develop specialty certificates and to increase public awareness of professional services.
Governance	Governed by a Council with government appointed public representatives and MRTs elected by the membership	Governed by a Board of Directors, elected by eligible members of the association.
