SAMRT'S ROLE The Saskatchewan Association of Medical Radiation Technologists (SAMRT) under the authority of the Medical Radiation Technologists Act, 2006 (the Act) regulates the practice of medical radiation technologists. The SAMRT does this by ensuring: Only those that meet education and character requirements are granted a license. All registrants remain current in practice through completion of required practice hours and continuing education requirements. Providing a process to address any professional misconduct or professional incompetence related to their registrants. VISION

The Saskatchewan public has access to safe medical imaging and radiation therapy delivered by highly skilled and valued professionals.

To protect the public by demonstrating regulatory excellence of medical imaging and radiation therapy professionals in the province of Saskatchewan.

THE PLANNING PROCESS

The planning session was a one-day workshop led by an external facilitator. Participants included members of the SAMRT Council, the staff of SAMRT, and key stakeholders and partners including representatives from the Saskatchewan Association of Diagnostic Medical Sonographers, the Ministry of Health, the Saskatchewan Health Authority, and the Saskatchewan Medical Imaging Managers.

The planning process is supported by a committee of the council, the Planning Committee, who, in advance of the planning session, undertook preparatory work. The committee then used the workshop outputs resulting in this strategic plan, approved by council.

Public protection is at the forefront of our decisions

Defining Future State:

The Planning Committee examined the Vision, Mission, and Values developed as part of the previous strategic plan and proposed amendments. These amendments were subject to scrutiny by the workshop participants working in three groups. The results of the group work were discussed collectively by all participants and final statements were agreed upon.

Environmental Scanning:

Once the ideal Future State was understood and shared, the participants proceeded to analyze the SAMRT's current state. Participants reviewed several documents provided for the process, including the Administration/Planning Committee's Environmental Scan, the Saskatchewan Health Authority's Roadmap, and the Ministry of Health's Strategic Plan. Participants then developed a SWOT analysis (strengths, weaknesses, opportunities, and threats) to better assess the current state. Finally, participants reviewed the results of the member survey.

The outputs from these exercises were prioritized by participants and contributed to the development of strategic directions for SAMRT. An extensive exercise was undertaken where draft strategic priority options were developed. These were sorted and themed, resulting in the strategic priorities.

STRATEGIC DIRECTIONS


The final strategic directions agreed to were:

- 1. Government, the public, health professionals and medical imaging and radiation therapy professionals, are aware of and value the profession.
- 2. The SAMRT supports the need for an increase of medical imaging and radiation therapy professionals in Saskatchewan.
- 3. An effective, integrated regulatory regime exists for medical imaging and radiation therapy professionals, including sonographers.

Themes that emerged from the workshop included:

- Increase professional visibility through public engagement and inter professional collaboration
- Provide effective awareness about MRTs to MRTs, Government and the public.
- Implement strategies to increase professional awareness aimed at government, public and other healthcare partners.
- Work with stakeholders to increase membership through additional training seats, training programs, and other recruitment and retention initiatives.
- The SAMRT will collaborate with the Government of Saskatchewan and the sonographers of the province to achieve regulation of these technologists.
- Create a sustainable operational infrastructure to support SAMRT program expansion.
- SAMRT regulates all medical imaging and radiation therapy professionals to ensure a skilled workforce (and have the capacity to do so).
